



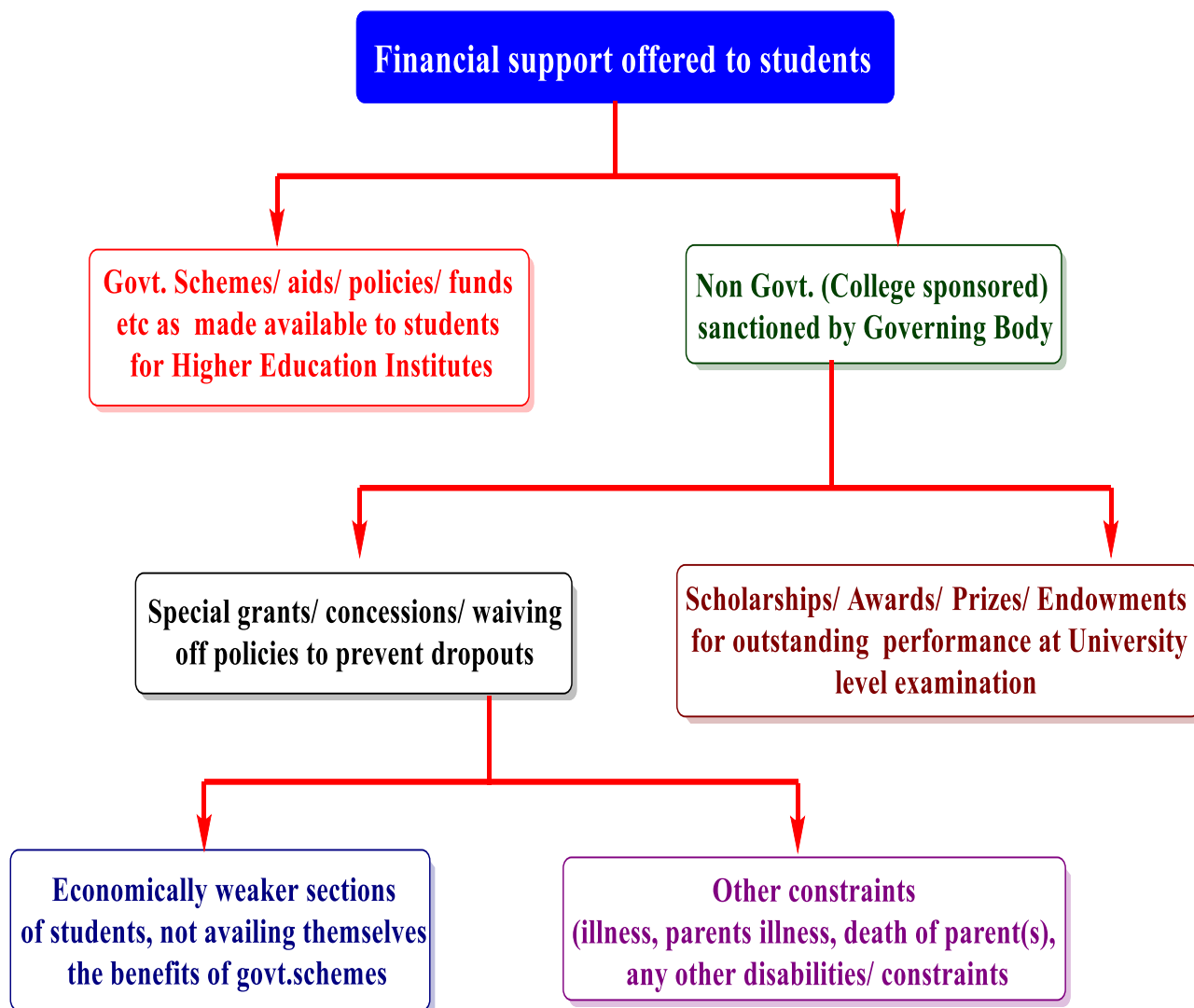

- **Application Process:**
